Dear stakeholder,

With just four weeks to go until the 31 October Brexit deadline, it is really important that you and your business are prepared and ready to continue importing and exporting goods after Brexit.

Since our last newsletter there has been further progress that will help you and your business get ready in good time.

# Imports: Registration is now LIVE for notification system for imports of animals or animal products from non-EU countries

If you import animals or animal products from non-EU countries you must register on the new IPAFFS IT system, which will replace the EU TRACES system for notification from 31 October.

Registration for IPAFFS is straightforward and open now. Full details on how to register can be found at <a href="https://www.gov.uk/ipaffs-registration">www.gov.uk/ipaffs-registration</a>.

#### **Exports: Multiple loads and Export Health Certificates**

A couple of newsletters back we talked about the <u>new process for exporting animals and products of animal origin to the EU after Brexit</u>.

We know that a key issue businesses like yours have been asking is what the Export Health Certificates (EHCs) requirements are for a lorry carrying multiple loads.

We have been working with industry to find a solution that is as easy as possible for exporters. However, the reality of the European rules are that multiple loads will need multiple EHCs. We understand that this will cause additional administrative effort but having an EHC for each category of load on board a lorry is the only way to help ensure your goods are not stopped or held up at the border. Guidance will shortly be updated on GOV.UK.

#### **Smarter Rules for Safer Food regulations coming in December**

The EU is introducing new rules to protect against animal disease and plant pests. The new Official Controls Regulation (EU) 2017/625 and Plant Health Regulation (EU) 2016/2031 will apply in EU member states from 14 December 2019. How and when the UK implements these regulations will depend on Brexit. UK exporters will need to comply with these regulations when they come into force in all Brexit scenarios. No changes are required at this moment, and we will have more detail on these changes in future newsletters but further information can be found <a href="https://example.com/here/best-scenarios/">here</a>.

## Trade Associations briefing sessions in October

Defra will be running a small number of free briefing sessions across the UK to help key Trade Associations understand the requirements for Brexit. Taking place in London, York and Bristol these sessions will aim to give trade associations all the information they need to inform their

members about the changes happening around importing and exporting animals, animal products and plants to and from the EU after Brexit.
