**Subject:** FW: CALL TO ACTION - 2 weeks to go until switch to IPAFFS for GB import notifications - POAO/CHED-P

Dear Importer/those responsible for the load,

We wrote to you on 19 August to tell you about forthcoming changes to the way in which you currently make GB import notifications from non-EU/third countries that were previously made in Traces Classic on a CVED-P (now CHED-P) .

There are now **2 weeks to go** before you need to notify the above imports on **IPAFFS**.

### **Reminder:**

**From Monday 7 September**, our intention is that notifications for POAO from non-EU countries currently made on Traces Classic using a CVED-P will be made on IPAFFS.

Live Animals and High-Risk Food and Feed not of animal origin will be available on IPAFFS soon and we will be in touch about these.

**Note:** Imports into Northern Ireland will move to Traces NT on 15th September with the intention to move to IPAFFS after the transition period.

Before the end of the transition period, **all** import notifications must be made on IPAFFS.

### **What you need to do now:**

#### **What you need to do from 7 September**

- Use IPAFFS for CHED-P imports to GB from 7 September 2020
- We will make the technical switch from Traces Classic to IPAFFS for GB imports at 6am on Monday 7 Sept 2020. You may experience some delays on consignments being released from 6am for approximately 30mins, as we make the switch from Traces Classic to IPAFFS. However, consignments that arrive after 6am should be notified on IPAFFS.
- Any consignments arriving after 6am but notified on Traces Classic or those that have not been cleared by 6am will require manual clearance via the National Clearance Hub
- Failure to enter this information onto IPAFFS may result in a delay to consignments.
